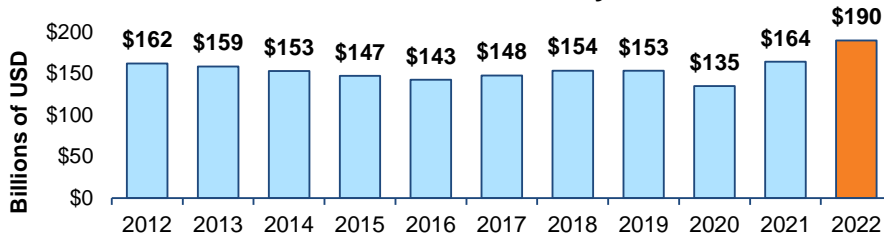


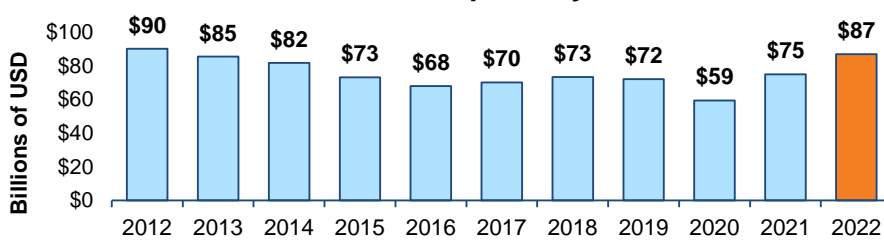
Florida Merchandise Trade - 2022

Total Merchandise Trade by Year



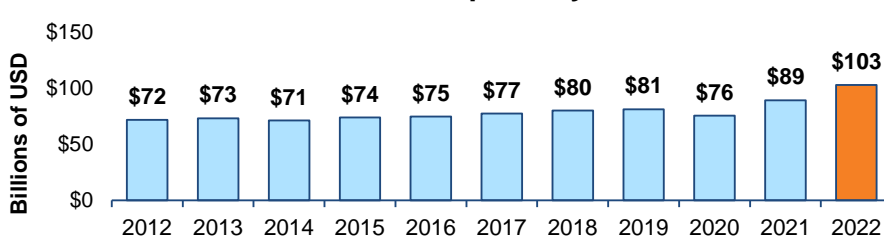
- Florida reached an all-time record of \$190 billion in **two-way merchandise trade** in 2022, growing by \$25.6 billion, an increase of 15.6%.
- The state's trade with the world has not only rebounded but grew by more than 40% since 2020.

Merchandise Exports by Year



- Merchandise exports gained 16.1%, increasing by \$12.1 billion to \$87 billion over 2021.
- Exports to Brazil alone of \$17.3 billion were almost as much as the next four countries combined.

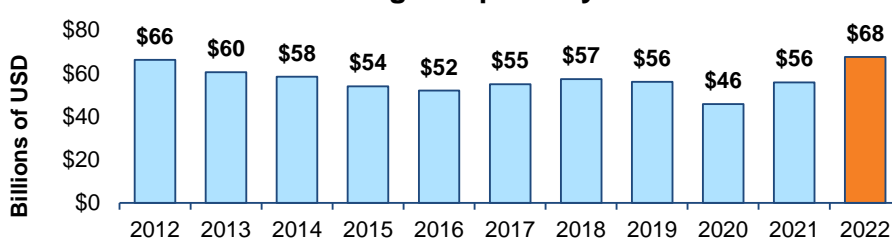
Merchandise Imports by Year



- Merchandise imports saw growth of 15.2%, an increase of nearly \$13.6 billion to a record \$103 billion.
- Those imports were also 36% higher than 2020.

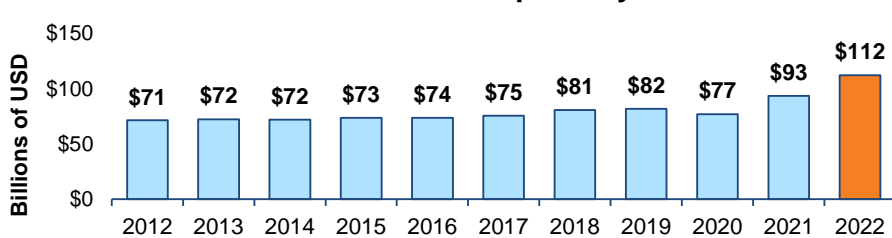
Florida Origin Exports and Florida Destination Imports - 2022

Florida-Origin Exports by Year



- **Florida-origin exports** hit an all-time record of \$67.5 billion in 2022, an increase of 21.1% and 47.6% more than 2020.
- The state ranks 6th in the U.S. among the largest exporting states in the country.

Florida-Destination Imports by Year

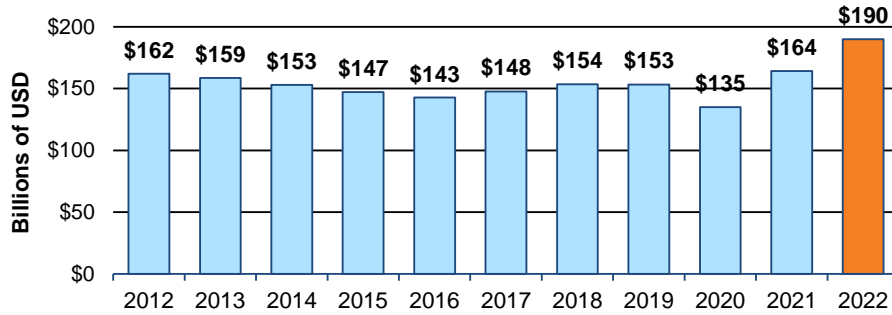


- **Florida-destination imports** also recorded an all-time record of \$112 billion in 2022, an increase of 19.8%, and 46% more than 2020.
- Florida is the 8th largest destination for imports into the U.S.

Total Merchandise Trade by Year



- Florida reached an all-time record of \$190 billion in **two-way merchandise trade** in 2022, gaining \$25.6 billion, an increase of 15.6%.
- The state's trade with the world not only rebounded since 2020 but grew by more than 40% since then.
- **Merchandise exports** gained 16.1%, increasing by \$12.1 billion compared to 2021.
- **Merchandise imports** saw growth of 15.2%, an increase of nearly \$13.6 billion.

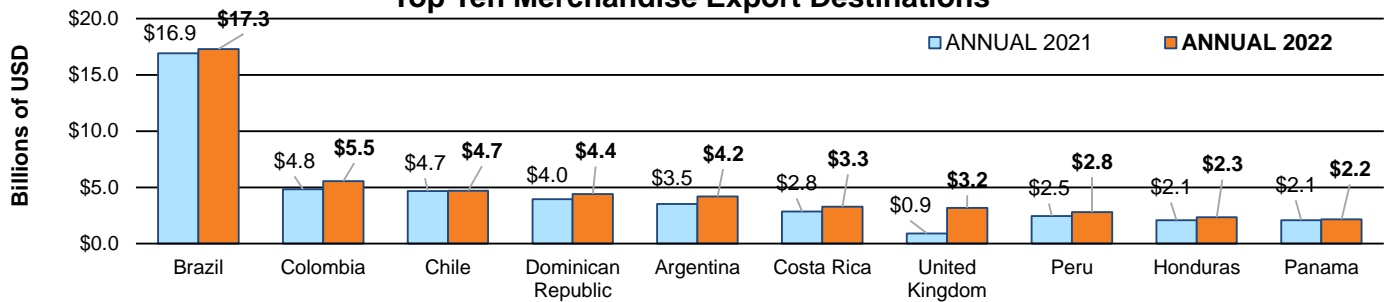

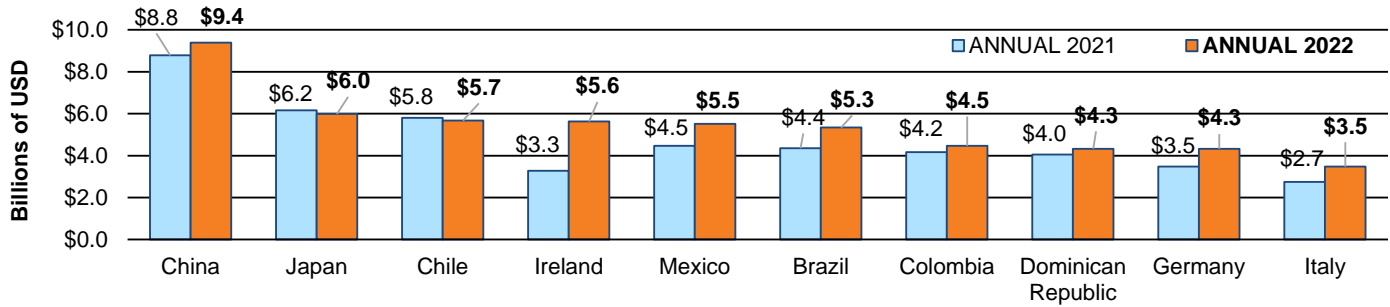

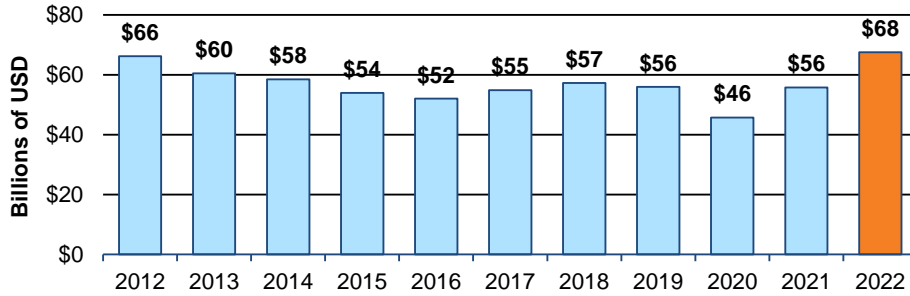

Florida-Origin Exports by Year



- *Florida-origin exports* hit an all-time record of \$67.5 billion in 2022, an increase of 21.1% and 47.6% more than 2020.
- The state now has **21 "billion dollar" export markets** with Brazil and Canada nearly tied at more than \$5 billion each.
- Nine of the state's top 10 export markets grew by double-digits in 2022, as did 16 of the top 20 markets.
- Florida **ranks 6th** among the largest exporting states in the U.S.

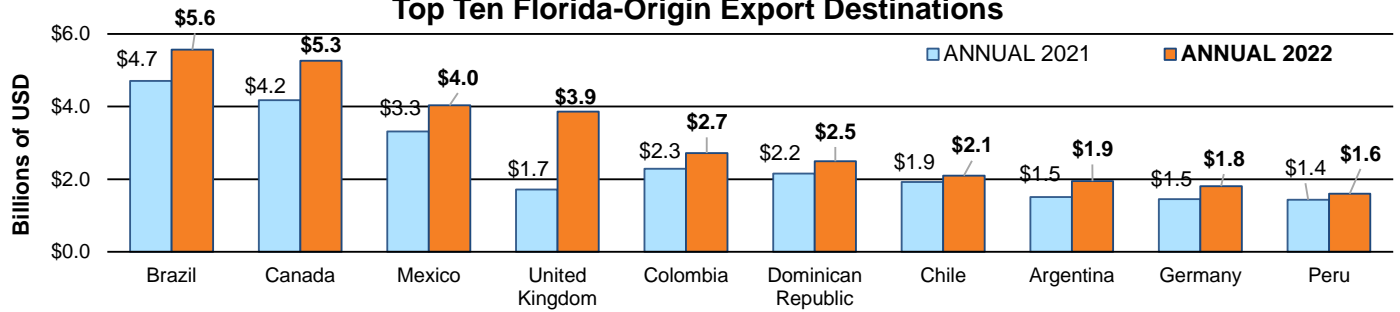

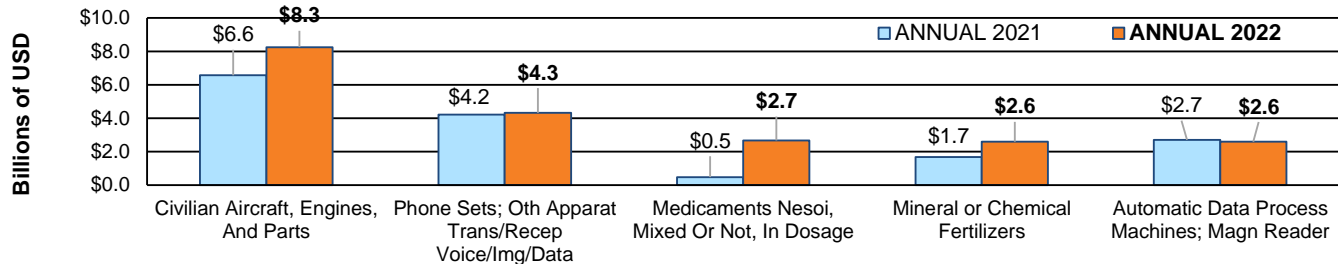

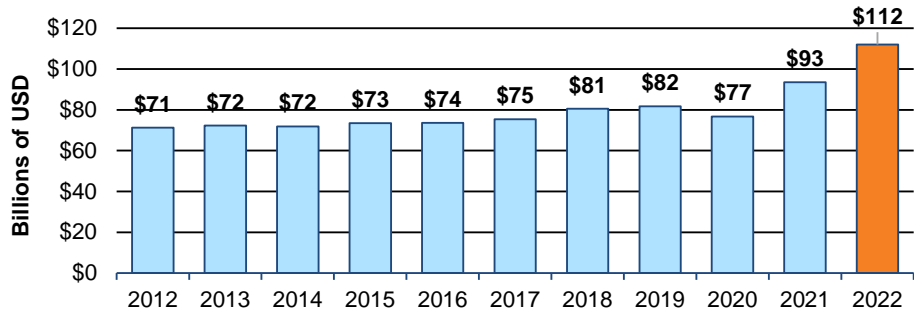

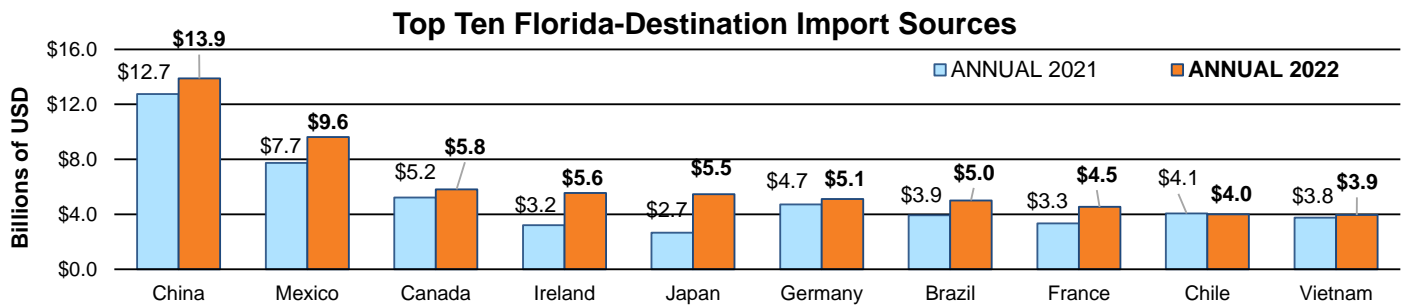

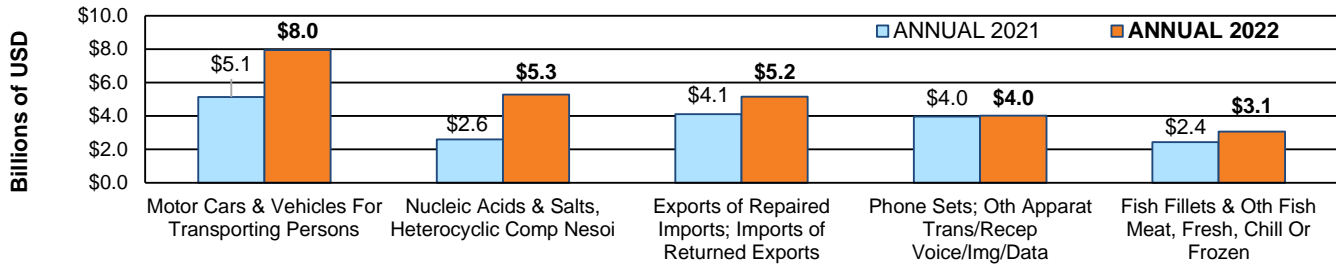
